## Notice of Surcharge Update

Dear Valued Customer,

Thank you for your continued support and for choosing Ocean Network Express (ONE) to cater to your needs.

Please be advised that from **1st October 2024**, we will provide new add-on service for an additional charge: **Container Maintenance Charge (CMC)** and **Container Cleaning Charge (CCC)** on import containers into Taiwan to reduce the administrative burden and speed up the container return process.

### Applicable Charge:

| Container Maintenance Charge (CMC) | Currency | Quantum | Remark                 |
|------------------------------------|----------|---------|------------------------|
| 20'/40'/HQ/45' foot Container      | TWD      | 2,000   | Cover up to TWD\$6,000 |
| Container Cleaning Charge (CCC)    |          |         |                        |
| 20' foot Container                 | TWD      | 500     | for Water Clean only   |
| 40'/ HQ / 45' foot Container       | TWD      | 700     | for Water Clean only   |

\*Above tariffs are not applicable for SOC and other conditions in contract.

- 1) Container Maintenance Charge (CMC): Once repairing charge is over TWD\$6,000, customer shall be responsible for the additional cost incurred.
- 2) Container Cleaning Charge (CCC): ONE still reserves the rights for the following cases to be added the separate charges:
  - Dunnage, trash, remove debris.
  - Chemicals requiring specialized cleaning.
- 3) Commodity excluded in this scheme: Quicklime / Grape / Metal Scrap

敬請注意，自 2024 年 10 月 1 日起，我們將對進口到台灣的貨櫃提供新的**加購服務**：**貨櫃維護費 (CMC)** 和**貨櫃清潔費 (CCC)**，以減少作業程序並加快空櫃交回流程。

### <貨櫃維護費 (CMC) >

- 20'/40'/HQ/45'：TWD 2,000 / box，涵蓋最高 TWD 6,000 的修櫃費用

### <貨櫃清潔費 (CCC) >

- 20'：TWD 500 (僅限水洗)
- 40'/HQ/45'：TWD 700 (僅限水洗)

\*上述收費標準適用**一般乾櫃及冷凍櫃**，不適用於特殊櫃、SOC 貨櫃及合約中其他條款的情況。

### <其他注意事項>

1. 貨櫃維護費 (CMC)：若維修估價超過 TWD 6,000，客戶需負擔超出的部分。
2. 貨櫃清潔費 (CCC)：ONE 保留以下情況收取額外費用的權利：
  - a) 貨物及包材的殘留、垃圾、碎片清理
  - b) 櫃場判定需要化學 or 特殊方式清洗 (則以化學/特殊清洗的全額費用再進行收費)
3. 不適用此服務的品項：Quicklime(生石灰) / Grape(葡萄) / Metal Scrap(金屬廢料)
